US AMLR Program marine mammal dataset

1.2. Summary description of the data:

As upper trophic level predators, pinnipeds are a conspicuous component of the marine ecosystem around the South Shetland Islands. They respond to spatio-temporal changes in physical and biological oceanography and Antarctic fur seals are the most abundant pinniped found at Cape Shirreff; shown here is a male (in back) and a female (silver color) with her pup. are directly dependent upon availability of krill for maintenance, growth, and reproduction during the austral summer. The Antarctic fur seal, *Arctocephalus gazella*, is the most abundant pinniped at Cape Shirreff and our studies are focused to a large degree on this species. Because of their current numbers and their pre-exploitation biomass in the Antarctic Peninsula and Scotia Sea regions, they are recognized to be an important krill-dependent upper trophic level predator. The general objectives for pinniped research at Cape Shirreff are to monitor population demography and trends, reproductive success, and status of pinnipeds throughout the summer months.
