Lineage Statement:

The HARP dataloggers are moored to the sea bottom and remain there for an extended

period of time (e.g., 6 mos. to 1 yr.). Passive acoustic data are collected by a single omnidirectional hydrophone and recorded on hard drives as (.hrp) . After the data loggers are retrieved the acoustic data are converted to .wav files.

Raw data (.hrp) are checked when initially copied from the drives to determine the total recording duration and assess errors in recording. Raw data are converted to .wav files that are checked during analyses of datasets.
